Kind attention is invited to the subject cited, where-in the Adhoc Committee formed under the Chairmanship of the Hon'ble Chairperson of A.P. Women's Commission, conducted enquiry regarding suicide of a minor girl student at Sri Chaitanya Engineering College, Kommadi, Visakhapatnam on 03.04.2024. It is observed that the Internal Complaints Committee was not formed and students have no idea of Internal Complaints Committee and there were no Complaints boxes in the campus and also not formed anti-ragging committees.

In this connection, the Hon'ble Chairperson of A.P. Women's Commission desires to address concerned Schools, Universities and their affiliated Colleges to send the status of ICC/LCC under Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act-2013 and also on Anti-Ragging cases.

In view of the above, the Departments and all Universities are hereby requested to furnish the same to all Colleges under your control and consolidate the data received from all Colleges and send the details of ICCs and status of cases under POSH and Anti-Ragging from dt.01.01.2023 to 31.03.2024 to this office on or before 30.04.2024 in the Annexures 1&2. It is also requested to send the report for every quarter, for onward placing the same before the Hon'ble Chairperson of A.P. Women's Commission.

Process to approach for help

In general the individual or class level grievances are expressed to the class in-charge lecturer or to faculty who regularly attend their classes. If not solved or satisfied, students are encouraged to use the Grievance / Suggestion Box which is placed at the building entrance hall. The complaint should be written in a paper mentioning the name and class of the student.

- Students can drop their complaints in the Grievance Box
- On every 1st and 15th of the month the members of Student Grievance Cell open the box and collect the complaints.
- The grievance redressal cell scrutinizes all complaints and necessary action is taken within a few days.
- Besides, there is an exclusive mechanism to address the issues relating to women and their grievances.
- The action taken for redressal is recorded and the same will be intimated to the students by means of a notice or through their faculty.
- The actions should be prompt for better redressal of Grievances.

In this regard all the Principals of Government Degree Colleges are obliged to constitute an Internal Complaint Committee through a written order to execute the orders of Hon'ble Supreme Court of India for the implementation of Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act 2013. Internal Complaint Committee has to be set up at Institution level and it will be composed of the following members and ensure complaints committee are trained in both skill and capacity to demonstrate knowledge in dealing with workplace sexual harassment issues/complaints. ICC member will hold their position not exceeding three years from the date of their nomination or appointment.

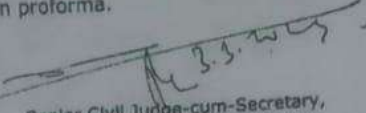
